

ORDINANCE # 11

ORDINANCE SETTING QUOTAS FOR THE NUMBER OF CAMPGROUNDS
PERMITTED IN THE TOWN OF KILDARE.

The Town Board of the Town of Kildare, Juneau County, Wisconsin, in order to promote the public health, safety, general welfare and good order in the Town of Kildare and for its inhabitants; to further the orderly layout and use of lands in the Town of Kildare; to prevent the overcrowding of lands; to lessen congestion of the streets and highways in the Town of Kildare; to provide for adequate light and air; to facilitate provisioning for water, sewerage and other public improvements; to provide for proper ingress and egress from public highways to private lands; to provide for the orderly development and growth of the Town of Kildare and to regulate campgrounds to promote the same, do ordain as follows:

Section 1

Quotas on campground licenses.

(a) In this subsection:

1. "License" means a campground license.
2. "Population" means the number of inhabitants determined by the last decennial federal census or special census conducted under contract with the U.S. bureau of the census.
3. "Quota" means the number of licenses which the Town Board may grant or issue.

(b) Except as provided in pars. (c) and (d), the quota of each municipality is the number of licenses issued in good faith in 1985, plus whichever of the following is the largest:

1. One license per 1,000 population or fraction thereof. A municipality's population, for purposes of determining its quota, may be adjusted on the basis of a special census only once during the period between decennial censuses.

2. The number of licenses lawfully issued and in force within the municipality on August 1, 1985.

3. The number of licenses lawfully issued and in force within the municipality in the year of the decennial federal census immediately prior to the most recent decennial federal census.

(c) If territory containing premises covered by a license is annexed to the municipality and if the municipality's quota would not otherwise allow licenses for the premises, the quota shall be increased to include a license for each premises in the annexed territory.

(d) Detachment of territory shall decrease the quota of the remainder of the municipality by the number of premises covered by licenses existing in the detached territory, except that detachment shall not decrease the quota of the remainder to less than one license per 1,000 persons or less than one license.

Section 2

Any permit applied for after the effective date of this Ordinance for any campground not previously licensed by the Town Board shall comply with all of the terms of Ordinance # 10 regulating mobilehome parks, including the provisions requiring environmental and agricultural impact statements.

Section 3

Should any section, clause or provision of this Ordinance be declared by a Court to be invalid, the same shall not affect the validity of the Ordinance as a whole or any part thereof, other than the part so declared to be invalid.

Section 4

All Ordinances or parts of Ordinances in conflict with any of the provisions of this Ordinance are hereby repealed.

Section 5

Any person violating any provisions of this Ordinance shall, upon conviction thereof, forfeit not more than \$200, together with all costs of prosecution and in default of payment of such forfeiture and costs shall be imprisoned in the County Jail until payment is made, but not exceeding thirty days for each violation. Each day a violation of any provision of this Ordinance exists shall be deemed to constitute a separate offense.

Section 6

This Ordinance shall be in force and effect from and after its passage and publication as provided by law.
